Presidents Report:

DKK President Karthryn Cassidy delivered a fantastic report on the individual success of members as well as the club achievements and news regarding 2010. Special mention was given to competition and grading results. Kathryn discussed many of the issues which have affected the club, and praised the members in their ability to overcome challenges and work together. Some of the club's future plans were also discussed including advertisement and PR, Children's classes, more focus on attending competitions abroad, and the continuation of the hard work that has always been associated with the club.

Treasures report:

Club Treasurer Martin Kiosew gave a report on the club's finances. He gave a breakdown of the estimated monthly income, as well as the real monthly out goings. He mentioned that the club is paying out a considerable amount for the use of Marino, and that efforts were being made to reduce training costs and the possibility of moving to a smaller and cheaper hall for weekday training. As it stands the club will be moving to a new hall shortly for Friday evenings. Martin also encouraged members to pay their fees on time, but reminded members that the club is willing to be flexible for members who may not be able to make regular payments.

- Before the Amendments to the constitution, Danny and Szymon raised points about the club's training program. Danny suggested that each month there would be an open Keiko session for all Kendoka to attend. This session would be a set menu of kihon waza and jigeiko, with the highest grades in attendance acting as motodachi. This discussion was interrupted by the Chair, to be discussed in AOB.

Amendments to the Constitution:

Only one amendment to the constitution was discussed. After suggestions and discussion from members, including the issue of insuring there is an odd number of board members to avoid hung vote's and stale mates, and the idea of the club making decisions as a whole.

3 ideas were discussed and voted on, the vote was passed for option C : which sees the proposed change to section 4.1 put in place, with a further amendment to section 4.5 b

To; *"Each board member only has one vote, in the event of a hung vote or a stalemate; the motion shall be put to the members to vote."*

Any Other Business:

The club's newest member Szymon Gardzielewski raised some interesting points regarding the club's training methods. From his experiences teaching in his own club and attending national team trainings in Poland, Szymon has offered to assist the club with creating new training programs.

Jorge Cordero and Danny Lennon mentioned that the club's training methods are based on a solid base coming from Toru Takenaga and Yanai Sensei, and that these methods have helped the club to progress and to remain stable for a number of years, both agreed with Szymon that the training program can be revamped and improved for 2011, they will work with the Vice president and other members to implement changes.
